#### Agenda Item #4 ~ Vision Statement

Regina Mahoney and Emily had reworked the vision statement with the help of the Advisory Group to make it shorter and more in line with the recommendations in the Planning Manual. The PC discussed the new vision statement and made a few changes. Deb Shelby moved that the PC accept the vision statement. Linda Baker seconded. The motion passed (4-0). The vision statement will be presented at Town Meeting.

#### Agenda Item #5 ~ UWM Mapping Class

Carol Devlin explained that three students in the UVM Community Mapping class will be working with the PC on a set of maps. They will work on the MET (Maintain, Evolve and Transform) map and will be present at Town Meeting to talk with residents about their comments on the map and suggestions for priorities. They will do additional maps based on interviews with a minimum of eight residents. Carol is recruiting residents for the interviews.

- The Senior Forum was held on Saturday, February 6 and attended by eight people. The summary of comments will be used to inform discussions of the Town Plan.
- Carol Devlin informed the PC that a candidate for the Zoning Administrator's position and the Select Board are currently in negotiations.
