Agenda Item 4 ~ Town Plan Review Draft to Submit to the Select Board

Emily Nosse-Leier explained that the CCRPC had reviewed the document and considered the plan to be strong. It is believed that the plan will hold up in court to the best of the CCRPC's planners' ability. They recommend submitting it to the Select Board.

Key areas of discussion included economic development, preservation of archeological and historic structures, continuing the discussion regarding driveways and steep slopes when the PC reviews the Bolton Land Use and Development Regulations, protecting natural resources, protecting ground water, the forest district and forest management, constraints on development, conserved land, and the river corridor overlay district. Minor changes were suggested and approved.

Deb Shelby moved that the Planning Commission approve the Bolton Town Plan as amended on March 23, 2017 and submit it to the Bolton Select Board on March 24, 2017. Steve Barner seconded. The motion carried 5-0.
